

Summary of Financial Assistance for clubs from the Boxing Saskatchewan Grassroots Program - Nov 2018

Re: Financial Assistance from Boxing Saskatchewan Grassroots Program

This document is a summary of the "financial assistance for clubs" that is contained in the original document. The full version of the Grassroots Program has been sent to every member club of Boxing Saskatchewan.

Attract New Boxers - (Advertising)

- 1. Boxing Saskatchewan will compensate each member club for advertising that is specifically for the purpose of attracting competition boxers. The maximum amount is \$700 per club and is available each Boxing Saskatchewan fiscal year. Clubs may advertise to attract members that are recreational or fitness members but these ads do not qualify for compensation, nor do ads that solicit both recreation/fitness and competitive. The intention of the \$700 is to cover additional advertising costs and not supplement existing expenditures by clubs.
 - Advertising must be preapproved by Boxing Saskatchewan Executive Director or Board Assignee.
 - Receipts showing that the pre-approved advertising was paid will be required in order to receive the compensation.
 - Clubs may wish to advertise more than once but compensation from Boxing Saskatchewan can only total a maximum of \$700 within the Boxing Saskatchewan fiscal year.
 - Any fraudulent claims will disqualify a member club from participating in the Grassroots Development program for a period of time determined by the board.

Example:

Club XYZ Boxing submits a newspaper ad to Boxing Saskatchewan to have it pre-approved. The ad gets approved and Club XYZ runs the ad and pays \$400 for the advertisement. Club XYZ submits a copy of the ad and the copy of the paid receipt to Boxing Saskatchewan and Boxing Saskatchewan issues a cheque to Club XYZ for \$400. Shortly thereafter Club XYZ goes through the same process a second time for a second ad. Club XYZ submits a copy of the second ad and a copy of the paid receipt for \$400 to Boxing Saskatchewan. Having already provided Club XYZ with \$400 previously, this time Boxing Saskatchewan issues a cheque for \$300 to Club XYZ.

Support the Training and Development of New Boxers – (New Competitors and Equipment)

- 1. Member clubs will receive \$50 for each competitive boxer registration that is greater in numbers than the year before. For example; Club XYZ registered 12 competitive boxers in 2015, in 2016 they register 20 competitive boxers, Club XYZ receives (8 x \$50) \$400 from Boxing Saskatchewan. Boxers moving from other combat sports do not qualify. Maximum amount available for a club in each calendar year is **\$500**.
 - The Boxing Saskatchewan Executive Director will do a count of each club's registered competitive boxers approximately two weeks before the Boxing Saskatchewan Annual General Meeting and then compare numbers to the same time the year prior. I cheque for the qualifying amount will be issued to each member club that qualifies for a payment. No notice is required by the member clubs in order to receive this award.
- 2. Member clubs that have 3 or more boxers have their first <u>non-exhibition</u> bout in the same calendar year will qualify to submit a receipt for boxing equipment they purchased in that same calendar year and they will receive reimbursement (up to a maximum of \$200) for the equipment expenditure. This is a once per year per club reimbursement allowance.
 - Each club must present the minimum three passports of the first time boxers to the head official after completion of the third (or more) boxer's first competitive bout.
 - Once the head official acknowledges that a club has within the year, at least three boxers with their first non-exhibition competitive bout, he will notify the Executive Director of Boxing Saskatchewan who will then contact the member club.
 - The qualified member club can then submit a paid receipt for equipment to Boxing Saskatchewan for reimbursement up to \$200.00

Support Competition Opportunities for New Boxers – (Doctor)

- 1. In addition to existing financial support, Boxing Saskatchewan will make available for each club that holds a sanctioned event an amount of \$400 to cover the cost of having a doctor conduct medicals and attend the bouts. This amount is to be paid directly from Boxing Saskatchewan to the doctor. Should clubs make arrangements for a doctor and the doctor volunteers their time. Those clubs will receive \$750 instead of \$500 for their first sanctioned bout. These additional compensation amounts apply to one sanctioned bout per club per calendar year.
 - The clubs should notify the Boxing Saskatchewan Executive Director of their intent to have the doctor's compensation applied.
 - Should clubs wish to forego the \$400 compensation and instead take the increased sanctioned bout award, they should notify the Boxing Saskatchewan Executive Director of their intent in writing.
